Ordinance No. 2025-307

AN ORDINANCE AMENDING THE CITY OF KEOTA, IOWA, 2017 MUNICIPAL CODEBOOK OF ORDINANCES - COMMUNITY PROTECTION

BE IT ENACTED by the City council of the city of Keota, Iowa:

SECTION 1. Title III, Chapter 8, Section 6 & 7 of the City of Keota, Iowa, 2017 Municipal Codebook of Ordinances, is hereby repealed and the following adopted in lieu thereof:

3-8-6 LICENSE FEE

The following license fees shall be paid to the City Clerk prior to issuance of any license:

| Application Fee | \$50.00 |
|-----------------|---------|
| Daily | \$10.00 |
| Weekly | \$30.00 |
| Mongthly | \$60.00 |

3-8-7 LICENSE ISSUANCE AND TERMS

If the City Clerk finds the application is completed in conformance with Section 3-8-5 of this chapter and the facts stated therein are found to be correct, the license fee paid and investigation of an applicant's business responsibility is found to be satisfactory, a license shall be issued within three business days, excluding weekends, and holidays, after it has been filed.

Upon approval and the issuance of a license, a peddler, solicitor or transient merchant, shall be permitted to set up and sell their wares after 1:00pm Monday thru Friday and throughout the day on Saturday and Sunday.

SECTION 2. REPEALER. That all other ordinances or parts of ordinances in conflict herewith are repealed.

SECTION 3. SEVERABILITY CLAUSE. That if any section, subsection, sentence, clause, or phrase of this ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The City Council of the City of Keota, Iowa, hereby declares that it would have passed this ordinance, and each section, subsection, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrased be declared unconstitutional.

SECTION 4. WHEN EFFECTIVE. This Ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
